Executive summary of the survey results

Based on the countries surveyed and the homeopathic and anthroposophic medicinal products questioned, a difference in the availability of HAMP is noticeable:

- Some countries have a better developed market of HAMP, such as France, Spain and especially Germany showing highest availability of most products and short delivery times if a product order has been placed.
- Specific brands of medicinal products with no therapeutic indication, reflecting the classical single remedy homeopathy, are often difficult to find immediately (i.e. without ordering). However, these products can mostly be delivered to customers after a product order has been placed. Of the two products questioned in the survey within this segment, Formica (rufa) was the hardest one to find.
- However, requesting homeopathic medicinal products for specific symptoms, i.e. medicinal products with a therapeutic indication, (instead of specific brands for these symptoms) results in much better direct availabilities.
 Self-medication seems to be well-developed for the indications surveyed.
- Anthroposophic medicinal products are seldom directly available in the countries surveyed. Only in countries with a
 more or less well functioning HAMP regulatory system, the products surveyed can be ordered and delivered
 accordingly, with Germany as best-in-class.
- The products' availability does not show significant differences across the geographical regions within the countries surveyed: the availability of the products questioned is more or less the same in big cities, middle-sized cities, and countryside areas.
- As regards registration or authorisation numbers, a validation of the products provided has been done by a qualified person and led to the following general statements:
 - In Spain none of the products provided carried an authorisation number.
 - In France most of the products did not show an authorisation number either.
 - In Germany and Bulgaria most of the products provided carried an authorisation number.
 - In Romania the situation could not be validated due to the loss of the pack with the samples on the postal way.

Project's objective:


Measure the availability of HAMP in the European market

It is ECHAMP's purpose to illustrate the availability of HAMP in countries with different regulatory situations: both regulatory environments which function for HAMP and regulatory environments which can be considered less well-functioning

Approach:

- Gather facts to objectively evaluate 'availability' in accordance with 'freedom of choice for treatment' of HAMP in the EU, and more specifically in five Member States
- The approach assumes that availability leads to freedom of choice

Overview of project timeline






WHO / HAI^(*) define 'availability' as the percentage of medicine outlets where a medicine is located on the day of the survey

This definition is widely used:









Method applied in a lot of scientific papers, e.g.:

- Medicines prices, availability and affordability in 36 developing and middle-income countries: a secondary analysis (Essential Medicines and Pharmaceutical Policies, WHO, Switzerland; HAI, The Netherlands; Harvard Medical School)
- The availability and affordability of selected essential medicines for chronic diseases in six low- and middle-income countries (Department of Chronic Diseases and Health Promotion, WHO, Switzerland; Department of Medicine, Policy and Standards, WHO, Switzerland; HAI, The Netherlands).

The WHO / HAI^(*) methodology tailored to ECHAMP's context resulted in 10 to 15 visits per country

Methodology: Adapt the WHO / HAI Standard Measuring Methodology to suit ECHAMP's question

Rationale for selection of Member States

The criteria for selection, and the selection of the sample countries for the survey were proposed to PwC by ECHAMP

The selection of Member States allows the results of the survey to supplement the data in a way which is meaningful for the European situation. In the survey, the availability of HAMP in two Member States of doubtlessly functioning HAMP regulatory environment (defining a certain standard of availability) is compared to that of three Member States where the HAMP regulatory environment is less favourable.

In summary, the following regulatory situations were tested in the survey:

- 'Old Western European' Member States with a well-functioning HAMP regulatory system: examples France and Germany
- 'Old Western European' Member State with a non-functioning HAMP regulatory system: example Spain
- 'New Eastern European' Member State with currently working HAMP regulatory procedures but short regulatory history: example Bulgaria
- 'New Eastern European' Member State with a short regulatory HAMP history where regulatory progress currently is not reported: example Romania

Local data collectors have used the 'mystery shopper' approach to gather 'availability' data on the predetermined set of HAMP

Data collectors have:

Visited medicine outlets without informing the pharmacist, i.e. the mystery shopper approach

Bought / ordered the predetermined set of medicinal products

Reported 'availability' of the products in data collection form (Excel format), among others:

- Response pharmacist
- Timeframe of acquiring products (from time of demand to moment of delivery)


Data collector **insisted** to the pharmacist that (s)he wanted to **have** the products It was recommended to visit pharmacies that are **not too close** to each other

Validated data collection form at the end of each day

Deliverables to and from the local data collection teams



France, Germany and Spain are categorised^(*) as the 'big' countries for which data is collected in 15 medicine outlets


Bulgaria and Romania are categorised^(*) as 'smaller' countries for which data is collected in 10 medicine outlets

Four homeopathic and two anthroposophic medicinal products have been selected to be surveyed

Four homeopathic and two anthroposophic medicinal products have been put forward for the 'availability' data collection.



Rationale for selection of medicinal products

The criteria for selection, and the selection of the test medicinal products for the survey were proposed to PwC by ECHAMP

The following principles and considerations were applied in the selection of medicinal products for the survey:

- A set of four medicinal products were defined in order to examine the availability of homeopathic medicinal products
 - Two medicinal products with no therapeutic indication reflecting the 'classical' single remedy homeopathy with its individual approach
 - Two medicinal products with a therapeutic indication, simulating homeopathic 'speciality' product lines
- Two additional products were defined in order to test the availability of anthroposophic medicinal products

As such, six products were defined – two each of three product types. For each product type described one specification is defined to simulate a common and frequent therapeutic need (demand) (also accessible to self-medication) and one additional specification representing a more specific situation (occurring not so frequently, rather implying a therapy situation possibly involving a doctor).

- In all countries surveyed, the visited medicine outlets were **licensed pharmacies** only.
- For each of the five countries, the local data collector had to **inform none of the pharmacists surveyed** on the fact that (s)he was conducting a survey.
- As regards **registration or authorisation numbers**, a validation of the products provided (see Annex, p. 44) has been done by a qualified person and led to the following general statements:
 - In Spain none of the products collected carried an authorisation number.
 - In France most of the products collected did not show an authorisation number either.
 - In Germany and Bulgaria most of the products collected carried an authorisation number.
 - In Romania the situation could not be validated due to the loss of the pack with the samples on the postal way.

Results of the survey Bulgaria

GENERAL SURVEY RESULTS

- The local data collector could only collect a few homeopathic medicinal products which were part of the survey. More specifically, pharmacists could only provide the local data collector with homeopathic products for conditions such as common cold or flu, and stress or exhaustion.
- In a few cases phytotherapeutic medicinal products or food supplements were provided instead of homeopathic medicinal products.
- The anthroposophic medicinal products of WALA and WELEDA which were part of the survey, are not yet placed on the Bulgarian market, hence not available in the pharmacies.
- As a result, the local data collector could not place orders for the medicinal products which were not directly available. Nevertheless, some pharmacists expressed curiosity about the products and asked the data collector e.g. where the company is coming from or started looking for the company on the internet.
- Despite the poor availability of the requested products, pharmacists seemed generally happy to promote and describe homeopathic products.


DETAILED SURVEY RESULTS

- In none of the pharmacies surveyed, Pulsatilla was available. However, two pharmacists (out of the 14 pharmacists visited) showed interest and started searching for the company on the internet.
- The same availability results are noticeable for Formica (rufa): none of the pharmacies visited could HP2 provide the local data collector with the product. Again, two pharmacists showed interest and asked where the company was from.
- Homeopathic medicinal products against common cold or flu are largely known in the market and HP3 were immediately available for purchase in all pharmacies visited. The most common products are e.g. Coryzalia, Gripp Heel, Influcide and Oscillococcinum.
- Homeopathic medicinal products against stress or exhaustion are also well known in the market and were directly available in all the pharmacies visited. Pharmacists mostly recommended HP4 Sedatif PC. Some recommendations given by a couple of pharmacists: the same products in tablets, product praised as being efficient, medicine not to be taken during summer due to light-sensibility...
 - No anthroposophic medicinal products were available for purchase or ordering. As a result, Bulgaria has no availability for WALA Aurum / Stibium / Hyoscyamus Globuli and WELEDA Aurum / Hyoscyamus comp. Liquid dilution, nor for WALA Mercurialis Salbe and WELEDA Mercurialis perennis 10% Salbe.

GENERAL SURVEY RESULTS

- When leaving out Formica (rufa), which was rarely directly available in the pharmacies surveyed, nearly all requested homeopathic medicinal products were available when the local data collector surveyed the pharmacy.
- The predetermined anthroposophic products had generally no direct availability, because the products were out-of-stock or because the products were in general not sold by the pharmacist. In the latter case, pharmacists advised the local data collector to go to another pharmacy.
- Delivery lead times when ordering products (i.e. from time of demand till moment of delivery) ranged from next day deliveries to products available 6 business days after the pharmacy visit.

DETAILED SURVEY RESULTS

The direct availability of Pulsatilla in the pharmacies surveyed is high (i.e. in 13 out of the 15 pharmacies surveyed). One pharmacy placed an order and delivered the product accordingly. Another pharmacy advised the local data collector to go to another pharmacy so to get the product. In two cases, the purchased product did not show a brand label but had a pharmacy's label instead. Moreover, the term "homeopathic medicinal product" was not stated on the product.

Only a few pharmacies (in particular 2 out of the 15 pharmacies surveyed) had Formica (rufa) directly available to the local data collector. Most of the pharmacists could order and deliver the product accordingly. In some cases (i.e. at 4 pharmacies), the pharmacist did not sell Formica (rufa) and advised the local data collector to go to another pharmacy in order to get the product. Again, in two cases, the purchased product did not show a brand label but had a pharmacy's label instead. Moreover, the term "homeopathic medicinal product" was not stated on one of the these two products.

All of the pharmacies surveyed could provide the local data collector with a homeopathic medicinal product against a common cold / flu. The most common product recommended by pharmacists was Oscillococcinum. Two pharmacists even recommended two products (Oscillococcinum and Lehning 52, and, Serum de yersin and influenzinum) as they explained that these products are complementary.

DETAILED SURVEY RESULTS

As for the homeopathic products against common cold / flu, all of the pharmacists surveyed could instantly provide the local data collector with a homeopathic medicinal product against stress / exhaustion. The most common product recommended by pharmacists was Sedatif PC. Again, one pharmacist even recommended two products (Gelsemium and Ignatia).

With regard to the anthroposophic products WALA Aurum / Stibium / Hyoscyamus Globuli and WELEDA Aurum / Hyoscyamus comp. liquid dilution, only one pharmacy could immediately serve the local data collector. However, it concerned a substitute product, namely Aurum D20. The pharmacists visited explained the local data collector that the reasons for the products not being directly available, were out-of-stock on the one hand, or the products not being sold in the pharmacy surveyed on the other hand. In the latter case, the pharmacist did not place an order, but advised the local data collector to go to another pharmacy. One pharmacist, who ordered the product, even asked the local data collector whether (s)he discovered the products in Germany. Two ordered products, did also concern substitute products (i.e. Hyoscyamus D20 and Aurum D10).

None of the pharmacies visited, had WALA Mercurialis Salbe nor WELEDA Mercurialis perennis 10% Salbe directly available. The same story as for the other anthroposophic medicinal product questionned, AP2 holds for this products. Reasons for the products' non-direct availability are out-of-stock (but order placed consequently) or not being sold by the pharmacist. In the latter case, the pharmacist advised the local data collector to go to another pharmacy.

With the exception of three magistral preparations, all purchased and collected medicinal products showed an **identification number**, which is an **authorisation number**.



Results of the survey Germany

GENERAL SURVEY RESULTS

- In general, the four homeopathic products which are part of the survey, could be collected in most of the pharmacies. Where the products could not be found due to out-of-stock reasons, an order was placed. The most exceptional homeopathic product is Formica (rufa) which seems to have a very small demand in the market.
- The two anthroposophic products which are part of the survey, were generally not directly available due to out-of-stock reasons. However, both products could be easily ordered and collected.
- The pharmacists could order the demanded products in all cases from their wholesaler. If the pharmacist's wholesaler did not have the product in stock, (s)he could order it from another wholesaler. The big exception was Formica (rufa): in some cases the pharmacists ordered it from their wholesaler, in other cases they ordered it from an international company or the product was not deliverable at all.
- Delivery lead time depends on the availability, but also on the time of order and the weekday. Delivery on the weekend needs more time.
 In general, most products were delivered within the same day.

Results of the survey **Germany**

DETAILED SURVEY RESULTS

Only a few pharmacies had Pulsatilla (C12 or higher) in stock, but it was always deliverable. D-HP1 potencies are more common and as such, more directly available. Some pharmacies, specialised in homeopathic sciences, had special little packed tubes of Pulsatilla.

HP₂

Formica (rufa) is the most exceptional product of the list of products surveyed as it seems to have a very small demand in the market. It is more common in D-potencies than C-potencies and its delivery is often difficult. As such, some pharmacists provided D-potencies instead of C-potencies, and also lower dilutions than the equivalent to C-12 or higher. Some pharmacies could not order it from their wholesaler, but had to order it from an international company. In one case the local data collector had to pay extra postal charges for the delivery from abroad. Of all visited pharmacies, there was none that had Formica (rufa) in stock in any potency – even the specialised pharmacies did not have Formica (rufa) directly available. One pharmacy said that Formica (rufa) was deliverable from abroad, but sent a letter after a few days saying that Formica (rufa) existed only in D-potencies and consequently sent the money back.

Results of the survey Germany

DETAILED SURVEY RESULTS

- Pharmacists often recommended Ferrum phosphoricum or Meditonsin against common cold. A few pharmacists explained that it was difficult to find a homeopathic product that treats common cold, because every homeopathic product treats only specific symptom. One pharmacy even sold an anthroposophic product as homeopathic product, because it was produced in a homeopathic way.
- The most popular homeopathic products against stress / exhaustion in the market seem to be Neurexan or Hypericum. One pharmacy sold an anthroposophic product as a homeopathic product, because it was produced in a homeopathic way.
- Many pharmacies did not have WALA Aurum / Stibium / Hyoscyamus Globuli nor WELEDA Aurum / Hyoscyamus comp. liquid dilution in stock, but they were in equal measure deliverable. One pharmacy delivered a wrong product (WALA Aurum / Strophanthus Globuli).
- Many pharmacies did not have WALA Mercurialis Salbe nor WELEDA Mercurialis perennis 10% Salbe in stock, but they were in equal measure deliverable.



Geographical areas surveyed Romania

It was not possible to validate the identification numbers described by the data collector due to a loss of the pack with the samples on the postal way.



Results of the survey Romania

GENERAL SURVEY RESULTS

- In Romania, various homeopathic products may be found in drugstores, which are allowed to sell homeopathic OTC medicinal products. Nevertheless, the survey only focused on licensed pharmacies.
- Generally, the homeopathic products which are part of the survey, were found in most of the pharmacies. Where the products could not be found, an order was placed and the pharmacist informed the local data collector that the product could be delivered in maximum one week.
- With regards to the anthroposophic products, the Romanian legislation does not recognise them in the sense that they are not specifically regulated. However, the predetermined anthroposophic medicinal products have been asked for to the pharmacist. Nevertheless, these could not be found / ordered from any of the pharmacies visited. Some of the pharmacists informed the local data collector that there is no Romanian importer which can make available these products and a direct order from the producer is not possible. Other pharmacists were not even familiar with the existence of these products.

HP₁

Pulsatilla was directly available in many of the pharmacies visited, more specifically in 6 out of the 10 pharmacies visited. The purchased products were Pulsatilla CH 15 and CH30. When being outof-stock (which was the case in one pharmacy), the pharmacist ordered and delivered the product. Some pharmacies (i.e. 3 out of the 10 pharmacies surveyed) did not deliver the product as they stated that the product was not commercialised in their pharmacy. The pharmacists told the local data collector that (s)he had never sold this remedy and that (s)he cannot order it.

Only in two pharmacies surveyed, the homeopathic medicinal product Formica (rufa) was directly available. Some pharmacists did not have the product in stock but ordered it for the local data collector. Again, the collected products were Formica (rufa) CH 15 and CH30. However, the major HP2 part of the pharmacists (i.e. 5) informed the local data collector on the fact that Formica (rufa) is not commercialised in their pharmacy because there are no requests for it (from clients). Two of them tried to make the product available to the local data collector, but informed him / her afterwards (via phone) that it was not possible.

All pharmacists surveyed were able to recommend and directly deliver a homeopathic medicinal product against common cold / flu. The products collected were mainly Oscillococcinum, Stodal and Homeogene 9. One pharmacist told the local data collector that the homeopathic doctor should have recommended a remedy and that (s)he should not ask the pharmacist for a specific medicine. However, when insisting, the pharmacist was willing to provide Oscillococcinum.

Also when requesting a homeopathic medicinal product against common stress / exhaustion, all pharmacists surveyed were able to recommend and directly deliver a product. The products collected were mainly Sedatif PC. The local data collector asked to one pharmacist if (s)he could provide another similar product – instead of Sedatif PC, but the latter was the only one available.

None of the pharmacies visited had WALA Aurum / Stibium / Hyoscyamus Globuli nor WELEDA Aurum / Hyoscyamus comp. liquid dilution in stock, because the products are not commercialised in the pharmacy and they could not be ordered because there is no Romanian importer for it. Moreover, many pharmacists informed the local data collector that (s)he never heard of these medicinal products. Two pharmacists explained that they cannot order the products from Germany as they generally acquire medicines from an importer.

Also for WALA Mercurialis Salbe and WELEDA Mercurialis perennis 10% Salbe, none of the pharmacists surveyed, commercialise these products and consequently do not have them available as there is no Romanian importer for these products. A couple of pharmacists admitted that they had

never heard about the WALA and WELEDA products.

GENERAL SURVEY RESULTS

- In general, the four homeopathic products which are part of the survey, are in most cases immediately available, except for Formica (rufa). None of the surveyed pharmacies had the product Formica (rufa) in stock, however, it was always deliverable within a reasonable time frame.
- Anthroposophic products were difficult to find immediately. However, there was in general no problem in ordering the first anthroposophic product of the list to be surveyed in most of the pharmacies. In a couple of cases, once the second anthroposophic product to be surveyed was ordered, the pharmacist phoned the local data collector afterwards to cancel the order due to the unavailability of the latter product.
- The main reasons for products not being directly available are out-of-stock and a lack of knowledge on homeopathic and anthroposophic products of the pharmacist.
- The time between order placement and order delivery was generally a couple of days, with a maximum of 5 working days.

- HP1 In many cases, Pulsatilla was directly available. Besides, it was always deliverable when ordered.
- None of the surveyed pharmacies had the product Formica (rufa) available at hand. However, every pharmacist visited could order and deliver the product.
- The large majority of visited pharmacies (i.e. 14 out of 15 pharmacies surveyed) could immediately deliver a homeopathic product against a common cold or flu. Only one pharmacist did not have anything in stock, but ordered a product accordingly. The most common product recommended by the pharmacist was Oscillococcinum.
- A homeopathic product against stress / exhaustion was also directly available in most of the pharmacies visited. However, in the other cases (i.e. 3 out of the 15 pharmacies surveyed), pharmacists had not enough knowledge about possible references they could recommend and as such, could not provide the local data collector with an appropriate product.
- Only a small number of pharmacies had the WELEDA Aurum / Hyoscyamus comp. liquid dilution product in stock. In general, pharmacists could however deliver it after ordering the product. Nevertheless, many pharmacists reported that they did not know WALA Aurum / Stibium / Hyoscyamus Globuli.

AP2

None of the visited pharmacies had WALA Mercurialis Salbe nor WELEDA Mercurialis perennis 10% Salbe in stock. Many pharmacists informed the local data collector that they did not know WALA Mercurialis Salbe. Furthermore, only a few pharmacists (i.e. 3 out of 15 pharmacists visited) were able to order and deliver the WELEDA Mercurialis perennis 10% Salbe. The others explained the unavailability of WELEDA Mercurialis perennis 10% Salbe by stating on the one hand that the product is not produced anymore (some pharmacists even ordered the product and phoned the local data collector afterwards to cancel the order due to the product's unavailability), or on the other hand that they did not know these products.
